THEREFORE BE IT RESOLVED that the County Board of Supervisors directs that \$16,947 be reserved for the purpose of providing property tax relief to the above levies and the remaining \$16,947 be reserved for the purposes of infrastructure funding in the 2001 – 2002 budget under the general basic fund.
