WHEREAS, the federal privacy rule implemented under the Health Insurance Portability and Accountability Act (HIPAA) provides for standards for confidentiality of health information. The privacy rule applies to health care providers and payers for health care services, among other entities. The implementation for the Rule is April 14, 2003.

WHEREAS, the Iowa County Board of Supervisors has determined that Iowa County is a "hybrid entity" within the meaning of the privacy rule, which means it has certain offices or departments that are covered by the rule.

WHEREAS, Iowa County is fully committed to compliance with the federal privacy rule to the extent it is applicable to Iowa County.

NOW, THEREFORE, BE IT RESOLVED that the Board has determined that the following offices or departments are covered by the HIPAA privacy rule either because they provide health care or pay for health care services, or they render services to or on behalf of those offices or departments that do:

1. Social Service 2. Health Department 3. Auditor's Office 4. Sheriff's Office 5. County Attorney's Office

These office and departments will be considered "covered components" of Iowa County. In addition, the Board of Supervisors designates itself as covered by HIPAA to the extent that it has access to or receives confidential health information from covered components of Iowa County.

To comply with the HIPAA privacy rule and to protect and promote the confidentiality of health information of its residents, Iowa County shall:

- a. Designate as Privacy Officers Marilyn Austin, Central Point of Coordination Administrator, and Gina Maas, Nurse Administrator, Health Department, who will report to the Board of Supervisors and who will be responsible for establishing policies and procedures as required by the HIPAA privacy rule and promoting compliance with those policies and procedures by the covered components of the County and vest the privacy officers with the appropriate authority to enforce compliance to the extent appropriate.
- b. Designate a privacy committee that will report to the Board of Supervisors and that will assist the privacy officer in establishing policies and procedures and ensuring compliance with those policies and procedures by the covered components of the County.
- c. Direct the privacy officers and privacy committee to establish policies and procedures, subject to the Board's approval, to promote compliance with the HIPAA privacy rule by the covered components of the County.
- d. Vest authority in the privacy officer and privacy committee to enforce as appropriate compliance with the HIPAA privacy rule.
- e. Direct the covered departments and offices to continue to take reasonable steps to promote the privacy and security of health information protected by the federal privacy rule.
