WHEREAS, the tax and revenues to be collected from the Hotel Tax have not heretofore been pledged and are available for the proposed Bonds; and

WHEREAS, in lieu of calling an election to institute proceedings for the issuance of the Bonds, the County desires to cause a notice of the proposal to issue the Bonds, including statement of the amount and purpose of the Bonds, together with the maximum rate of interest which the Bonds are to bear and the right to petition for an election, under the provisions of Section 422A.2(4)(f), to be published at least once in a newspaper of general circulation within the County at least 10 days prior to the meeting at which it is proposed to take action for the issuance of the Bonds;

NOW, THEREFORE, It Is Resolved by the Board of Supervisors of Iowa County, Iowa, as follows:

- Section 1. Pursuant to Chapter 422A, the County hereby affirms the imposition of the Hotel Tax and ratifies any and all action taken heretofore with respect thereto.
- Section 2. The 26th day of March, 2004, at the Courthouse, in the City of Marengo, at 9:30 o'clock a.m., is hereby fixed as the time and place proceedings will be instituted and action taken for the issuance of the Bonds.
- Section 3. The County Auditor is hereby directed to give notice of the proposed action for the issuance of the Bonds setting forth the amount and purpose thereof, the maximum rate of interest which the Bonds are to bear, the time when and place where the said meeting will be held, and the right to petition for an election, by publication at least once, and not less than 10 days before the meeting, in a legal newspaper published at least once weekly, and of general circulation in the County.

The notice shall be in substantially the following form:

NOTICE OF PROPOSED ACTION TO INSTITUTE PROCEEDINGS FOR THE ISSUANCE OF HOTEL MOTEL TAX REVENUE BONDS IN AN AMOUNT NOT TO EXCEED \$240,000

The Board of Supervisors of Iowa County, Iowa, will meet on the 26th day of March, 2004, at the Courthouse, in the City of Marengo, at 9:30 o'clock a.m., for the purpose of instituting proceedings and taking action for the issuance of Hotel Motel Tax Revenue Bonds (the "Bonds") in an amount not to exceed \$240,000 for the purpose of providing an economic development grant to the Amana Colonies Historical Site Foundation for use in the promotion of tourism in the County.

any simple misdemeanor punishable as a scheduled violation pursuant to a citation issued by the sheriff, the court shall assess a five dollar county enforcement surcharge for each applicable violation, with the surcharge going to the county general fund of the county where the citation was issued; and

**WHEREAS**, section 9 of House File 2569 requires that for this county enforcement surcharge to go into effect in a given county, the board of supervisors must adopt an enacting resolution;

THEREFORE, BE IT RESOLVED BY THE BOARD SUPERVISORS OF IOWA COUNTY that the Board adopts a five dollar county enforcement surcharge pursuant to House File 2569, with the surcharge to be assessed as of July 1, 2004.

- Section 2. The area identified in Section 1 hereof is hereby declared to be an urban renewal area, in conformance with the requirements of Chapter 403 of the Code of Iowa, and is hereby designated the Iowa County Urban Renewal Area.
- Section 3. The development of this area is necessary in the interest of the public health, safety or welfare of the residents of Iowa County, Iowa.
  - Section 4. It is hereby determined by this Board of Supervisors as follows:
  - A. The proposed urban renewal plan conforms to the general plan of the county as a whole;
  - B. Proposed economic development in the urban renewal area is necessary and appropriate to facilitate the proper growth and development of the County in accordance with sound planning standards and local community objectives.

Section 5. The urban renewal plan for the Iowa County Urban Renewal Area is made a part hereof and is hereby in all respects approved in the form presented to this Board

Section 6. All resolutions or parts thereof in conflict herewith are hereby repealed, to the extent of such conflict.

#### **ORDINANCE NO. 27**

An Ordinance Providing for the Division of Taxes Levied on Taxable Property in the Iowa County Urban Renewal Area, Pursuant to Section 403.19 of the Code of Iowa

BE IT ENACTED by the Board of Supervisors of Iowa County, Iowa:

Section 1. Purpose. The purpose of this ordinance is to provide for the division of taxes levied on the taxable property in the Iowa County Urban Renewal Area, each year by and for the benefit of the state, city, county, school districts or other taxing districts after the effective date of this ordinance in order to create a special fund to pay the principal of and interest on loans, moneys advanced to or indebtedness, including bonds proposed to be issued by Iowa County to finance projects in such area.

Section 2. Definitions. For use within this ordinance the following terms shall have the following meanings:

"County" shall mean Iowa County, Iowa.

"Urban Renewal Area" shall mean the Iowa County Urban Renewal Area, the description of which is set out below, such area having been identified in the Urban

Renewal Plan approved by the Board of Supervisors by resolution adopted on December 22, 2004:

All taxable property identified by County Parcel Number shown on Exhibit A to this Ordinance.

- Section 3. Provisions for Division of Taxes Levied on Taxable Property in the Urban Renewal Area. After the effective date of this ordinance, the taxes levied on the taxable property in the Urban Renewal Area each year by and for the benefit of the State of Iowa, the County and any city, school district or other taxing district in which the Urban Renewal Area is located, shall be divided as follows:
- that portion of the taxes which would be produced by the rate at which the (a) tax is levied each year by or for each of the taxing districts upon the total sum of the assessed value of the taxable property in the Urban Renewal Area, as shown on the assessment roll as of January 1 of the calendar year preceding the first calendar year in which the County certifies to the County Auditor the amount of loans, advances, indebtedness, or bonds payable from the special fund referred to in paragraph (b) below, shall be allocated to and when collected be paid into the fund for the respective taxing district as taxes by or for said taxing district into which all other property taxes are paid. For the purpose of allocating taxes levied by or for any taxing district which did not include the territory in the Urban Renewal Area on the effective date of this ordinance, but to which the territory has been annexed or otherwise included after the effective date, the assessment roll applicable to property in the annexed territory as of January 1 of the calendar year preceding the effective date of the ordinance which amends the plan for the Urban Renewal Area to include the annexed area, shall be used in determining the assessed valuation of the taxable property in the annexed area.
- that portion of the taxes each year in excess of such amounts shall be allocated to and when collected be paid into a special fund of the County to pay the principal of and interest on loans, moneys advanced to or indebtedness, whether funded, refunded, assumed or otherwise, including bonds issued under the authority of Section 403.9(1), of the Code of Iowa, incurred by the County to finance or refinance, in whole or in part, projects in the Urban Renewal Area, except that taxes for the payment of bonds and interest of each taxing district shall be collected against all taxable property within the taxing district without limitation by the provisions of this ordinance. Unless and until the total assessed valuation of the taxable property in the Urban Renewal Area exceeds the total assessed value of the taxable property in such area as shown by the assessment roll referred to in subsection (a) of this section, all of the taxes levied and collected upon the taxable property in the Urban Renewal Area shall be paid into the funds for the respective taxing districts as taxes by or for said taxing districts in the same manner as all other property taxes. When such loans, advances, indebtedness, and bonds, if any, and interest thereon, have been paid, all money thereafter received from taxes upon the taxable property in the Urban Renewal Area shall be paid into the funds for the respective taxing districts in the same manner as taxes on all other property.

- (c) the portion of taxes mentioned in subsection (b) of this section and the special fund into which that portion shall be paid may be irrevocably pledged by the County for the payment of the principal and interest on loans, advances, bonds issued under the authority of Section 403.9(1) of the Code of Iowa, or indebtedness incurred by the County to finance or refinance in whole or in part projects in the Urban Renewal Area.
- (d) as used in this section, the word "taxes" includes, but is not limited to, all levies on an ad valorem basis upon land or real property.
- Section 4. Repealer. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
- Section 5. Saving Clause. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.
- Section 6. Effective Date. This ordinance shall be effective after its final passage, approval and publication as provided by law.

#### **RESOLUTION #41**

Approving Development Agreement with Amana Nordstrom, Inc., Authorizing Tax Increment Rebates and pledging certain tax increment revenues to the payment of the Agreement

WHEREAS, the Board of Supervisors of Iowa County, Iowa (the "County"), pursuant to and in strict compliance with all laws applicable to the County, and in particular the provisions of Chapter 403 of the Code of Iowa, has adopted an Urban Renewal Plan for the Iowa County Urban Renewal Area (the "Urban Renewal Area"); and

WHEREAS, this Board has adopted an ordinance providing for the division of taxes levied on taxable property in the Urban Renewal Area pursuant to Section 403.19 of the Code of Iowa and establishing the fund referred to in Subsection 2 of

Section 403.19 of the Code of Iowa (the "Urban Renewal Tax Revenue Fund"), which fund and the portion of taxes referred to in that subsection may be irrevocably pledged by the County for the payment of the principal and interest on indebtedness incurred under the authority of Section 403.9 of the Code of Iowa to finance or refinance in whole or in part projects in the Urban Renewal Area; and

WHEREAS, an agreement between the County and Amana Nordstrom, Inc. has been prepared (the "Agreement"), pursuant to which Amana Nordstrom, Inc. has agreed to expand its Holiday Inn facility in the Urban Renewal Area (the "Holiday Inn Project") and the County has agreed to provide tax increment rebates in a total amount not exceeding \$500,000; and

WHEREAS, this Board of Supervisors, pursuant to Section 403.9 of the Code of Iowa, has published notice, has held a public hearing on the Agreement on December 22, 2004, and has otherwise complied with statutory requirements for the approval of the Agreement; and

WHEREAS, Chapter 15A of the Code of Iowa ("Chapter 15A") declares that economic development is a public purpose for which a County may provide grants, loans, tax incentives, guarantees and other financial assistance to or for the benefit of private persons; and

WHEREAS, Chapter 15A requires that before public funds are used for grants, loans, tax incentives or other financial assistance, a Board of Supervisors must determine that a public purpose will reasonably be accomplished by the spending or use of those funds; and

WHEREAS, Chapter 15A requires that in determining whether funds should be spent, a Board of Supervisors must consider any or all of a series of factors;

NOW, THEREFORE, It Is Resolved by the Board of Supervisors of Iowa County, Iowa, as follows:

Pursuant to the factors listed in Chapter 15A, the Board hereby finds that:

The Holiday Inn Project will add diversity and generate new opportunities for the Iowa County and Iowa economies;

The Holiday Inn Project will generate public gains and benefits, particularly in the creation of new jobs and tourism opportunities, which are warranted in comparison to the amount of the proposed property tax incentives.

The Board further finds that a public purpose will reasonably be accomplished by entering into the Agreement and providing the property tax rebates to Amana Nordstrom, Inc.

The Agreement is hereby approved and the Chairperson and County Auditor are hereby authorized and directed to execute and deliver the Agreement on behalf of the County, in substantially the form and content in which the Agreement has been presented to this Board of Supervisors, and such officers are also authorized to make such changes, modifications, additions or deletions as they, with the advice of bond counsel, may believe to be necessary, and to take such actions as may be necessary to carry out the provisions of the Agreement.

As provided and required by Chapter 403 of the Code of Iowa, the County's obligations under the Agreement shall be payable solely from a subfund which is hereby established, into which shall be paid that portion of the income and proceeds of the Urban Renewal Tax Revenue Fund attributable to property taxes derived from the property described as follows:

East 36.75 acres of NE1/4, 5-79-9; identified by County parcel numbers 16-05-0101-1 and 16-05-0101-2

(the "Amana Nordstrom Subfund").

The County hereby pledges to the payment of the Agreement the Amana Nordstrom Subfund and the taxes referred to in Subsection 2 of Section 403.19 of the Code of Iowa to be paid into such Subfund.

After its adoption, a copy of this resolution shall be filed in the office of the County Auditor of Iowa County to evidence the continuing pledging of the Amana Nordstrom Subfund and the portion of taxes to be paid into such Subfund and, pursuant to the direction of Section 403.19 of the Code of Iowa, the Auditor shall allocate the taxes in accordance therewith and in accordance with the tax allocation ordinance referred to in the preamble hereof.
