<u>Section 1</u>. The Commissioner of Elections of Iowa County, Iowa, is requested to cause to be submitted to the voters of the County the question of imposition of a local sales and services tax for school infrastructure purposes.

Section 2. It is the intention of this Board of Supervisors that the rate of the local sales and services tax for school infrastructure purposes be proposed as one percent (1%), with the tax to become effective beginning on January 1, 2006, and remain in effect for a period of ten (10) years thereafter until December 31, 2015.

Section 3. Moneys received from the local sales and services tax, if and when enacted and collected, shall be spent for school infrastructure as said term is defined by Iowa Code Section 423E.1, and the Commissioner of Elections of Iowa County is requested to so provide in the ballot measure, in the manner required by law and the regulations of the State Commissioner of Elections.

<u>Section 4</u>. The form of ballot is approved by this Board of Supervisors as follows:

SAMPLE BALLOT

SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED: Yes No

A local sales and services tax for school infrastructure projects shall be imposed in the County of Iowa at the rate of one percent. The tax will begin on January 1, 2006. The tax will be in effect for a period of ten years until December 31, 2015.

The money received from the tax shall be spent for school infrastructure as defined by Iowa Code Section 423E.1. "School infrastructure" is defined by law to include purchasing, building, furnishing, reconstructing, repairing, demolishing, expanding, improving or remodeling of a schoolhouse or schoolhouses and additions thereto, gymnasium, stadium, field house, or school bus garage, and procuring a site or sites therefore or purchasing land to add to a site already owned, or procuring and improving a site for an athletic field, or improving a site already owned for an athletic field, opening roads to schoolhouses or buildings, the purchase, lease or lease-purchase of buildings or equipment (including transportation and recreation equipment) as authorized by law, procuring or acquiring libraries, expenditures for energy conservation measures, the rental of facilities under Chapter 28E, the payment or retirement of outstanding bonds previously issued for school infrastructure purposes or the payment or retirement of bonds issued under Iowa Code Section 423E.5, for any one or more of such purposes, or for any purpose or purposes authorized by law.

<u>Section 5</u>. This motion and the motion representing the action of the School Districts are directed to be submitted to the County Commissioner of Elections for actions required by law.

RESOLUTION ESTABLISHING REQUIRMENTS FOR ISSUANCE OF FIREWORKS PERMITS

WHEREAS: The Board of Supervisors, Iowa County, Iowa, is empowered under the authority of Section 727.2, Code of Iowa, to grant a permit for the display of fireworks, by fair associations, amusement parks, and other organizations or groups of individuals approved by such county board of supervisors when such fireworks display will be handled by a competent operator, and

WHEREAS: the Board of Supervisors, Iowa County, Iowa, has received several requests for fireworks display permits, and

WHEREAS: the Board of Supervisors, Iowa County, Iowa, desires to grant permits only when a competent person will be in charge of the fireworks display to provide for the safety of all concerned.

NOW, THEREFORE BE IT RESOLVED by the Iowa County Board of Supervisors, that criteria should be and is HEREBY prescribed for the issuance of permits for the display of fireworks in Iowa County, Iowa.

BE IT FURTHER RESOLVED that the following definitions be used:

Applicant: The person or group who is applying for the permit.

Board: The Iowa County Board of Supervisors.

<u>Fireworks:</u> Any explosive composition, or combination of explosive substances, or articles prepared for the purpose of producing a visible or audible effect by combustion, explosion, deflagration, or detonation, and includes blank cartridges, firecrackers, torpedoes, sky rockets, roman candles, or other fireworks of like construction and fireworks containing any explosive or flammable compound, or other device containing any explosive substance. The term "fireworks" shall not include gold star-producing sparkles on wires which contain no magnesium or chlorate or perchlorate, no flitter sparklers in paper tubes that do not exceed one-eight (1/8) of an inch in diameter, toy snakes which contain no mercury, or caps used in cap pistols.

<u>Operator:</u> A person trained in fireworks safety who will set up and explode the fireworks.

Sponsor: The group paying for or otherwise providing for the fireworks display.

BE IT FURTHER RESOLVED that the applicant shall submit an application in writing on the form attached hereto and incorporated herein by reference.

BE IT FURTHER RESOLVED that no permit be issued until the chief of the fire department having jurisdiction over the site of the fireworks display has approved the location and fire prevention measures.

BE IT FURTHER RESOLVED that no permit be issued unless liability insurance coverage is procured to protect the applicant, sponsor, operator, and the public in an amount to be determined by the Board, but in no event less than \$300,000. Iowa County shall be listed as an additional insured on the liability policy, as evidenced by a Certificate of Insurance filed with the application for each display.

BE IT FURTHER RESOLVED that the applicant and operator be persons of not less than eighteen (18) years of age on the date of the proposed fireworks display.

BE IT FURTHER RESOLVED that the operator must meet the following fireworks safety requirement:

- a. Be certified as a Display Fireworks Operator by the Pyrotechnics Guild International, Inc. Such certification involves formal fireworks safety training, passing a fireworks safety test with an 80% rate of accuracy, and working with a guild member on at least three formal fireworks displays; or
- b. Possess a current, valid fireworks license issued by a state of the United States which requires formal safety training similar to that in a) above; or

c. Demonstrate an equivalent degree of formal fireworks safety training and experience to the satisfaction of the Board.

BE IT FURTHER RESOLVED that any fireworks that remain unexploded after the display shall be immediately disposed of or removed for storage or disposal in a safe manner by the operator who, upon the conclusion of the display, shall make a complete and thorough search for any unexploded fireworks or fuses thereof which have not exploded or functioned.

BE IT FURTHE RESOLVED that the Iowa County Sheriff or his or her designee may suspend any permit issued pursuant to this resolution should he or she determine that the health, safety, and/or welfare of the public requires the suspension, or should the applicant and/or operator fail to meet or follow the safety qualifications as set out in this resolution.

Motion by Gerard, seconded by Tibben to **instruct our attorney to draw up an agreement with the developers of the Amana Water Park** to fund 90% for six years, 85% for six years, and 80% for five years with a cap of \$12.5 million. The paving will be paid for by the developers and the Amana Society. No county funds will be used for paving purposes. Gerard – yes; Montross, Tibben, and Garringer – no. **Motion failed**
