Planning Update ESF 6,8,10,11 RSF- Humphrey gave an update on the plan updates for this year and that he had completed updates to several and is finishing ESF 10. He explained that RSF(recovery support function) is a new plan that has several parts and he will be working on part 1 this summer.

Rescue Building/ EOC Update- Humphrey provided a brief update that it looks like the building is still in progress but is really being slowed by material delivery and the weather. Have been told it will be available for sale July 1. Humphrey explained the total cost is \$546,000, EMA has been given a \$125,000 donation and the land has been donated. Humphrey also received a \$12,417 grant to help with some of the electronics in the EOC. The remaining \$408,583 is what will be paid for thru the Iowa County ARPA funds.

FY22 Budget Amendment #2 EMPG- ARPA Grant- Humphrey presented a budget amendment for the grant talked about in the line above to be amended into FY22 budget. Motion by Heitshusen to set public hearing for 5-19-22 at 6pm, second by Grier. All Ayes
