The Iowa County Board of Supervisors met on March 24, 2023. Heitshusen, Chairman called the meeting to order at 9:00 a.m. Heitshusen, Maas, Montross and Schumacher were present. Degen absent.

Motion by Maas, seconded by Montross to approve the agenda. All aye, motion carried.

Motion by Montross, seconded by Maas to **approve minutes** from March 17, 2023. All aye, motion carried.

Chair Note: The board approved handwritten claims paid with warrant numbers 21971 – 21976 and claims paid with warrant numbers 21977 – 22089. The Board received a Manure Management Plan from Walnut Meadows # 58851.

Motion by Maas, seconded by Montross to **approve liquor license** amendments for Hops and Hotrods LLC.; dba-Hops and Hotrods, Amana Society, Inc., dba-Amana Performing Arts Center; Amana Society, Inc., Amana Colonies Outdoor Convention Facility; Amana Society, Inc., Amana Society, Amana Colonies Outdoor Convention Facility. All aye, motion carried.

Motion by Maas, seconded by Montross to approve Iowa County Sheriff Union Contract, that becomes effective July 1, 2023. All aye, motion carried.

No action taken on Iowa County Secondary Roads Union Contract. Will be placed on the agenda for March 31, 2023.

Nick Amelon, Iowa County Engineer, met with the board to present his department's weekly update.

Motion by Maas, seconded by Maas, seconded by Montross to approve, and authorize the Chair to sign Final Pay Voucher – V52. All aye, motion carried.

Mary Rump, Regional Transportation Director - ECICOG met with the board to discuss RPA application review and priorities.

Motion by Maas, seconded by Schumacher to open the Public Hearing at 10:00 a.m. for FY 23-24 Max Levy. All aye, motion carried.

No written comments were received.

Oral Comment received from Vic Rathjen in objection to the FY 23-24 Max Levy.

Motion by Montross, seconded by Heitshusen to approve FY 23-24 Max Levy Resolution 2023-3-24 as follows:

RESOLUTION 2023-3-24 Maximum Property Tax Dollars Resolution WHEREAS, the Iowa County Board of Supervisors have considered the proposed FY 23-24 county maximum property tax dollars for both General County Services and Rural County Services, and

WHEREAS, a notice concerning the proposed county maximum property tax dollars was published as required and posted on county web site and/or social media accounts if applicable,

WHEREAS, a public hearing concerning the proposed county maximum property tax dollars was held on 3/24/2023,

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Iowa County that the maximum property tax dollars for General County Services and Rural County Services for FY 23-24 shall not exceed the following:

- General County Services: \$6,749,662; an increase of .82 % from the prior year
- Rural County Services: \$2,336,187; an increase of 8.83 % from the prior year

Ayes, Montross and Heitshusen. Nays, Maas and Schumacher. Degen, absent. Motion fail, tie vote.

The Max Levy Resolution will be placed on the next Iowa County Board of Supervisors meeting agenda.

Motion by Maas, seconded by Montross to close the Public Hearing at 10:09 a.m. for FY 23-24 Max Levy. All aye, motion carried.

The Department of Management was contacted to see if a new Notice of Public Hearing had to be published and the process started over, their guidance was that another public hearing does not need to be held, but the Board will need to have another board meeting to vote and approve the Max Levy Resolution. The Department of Management does not approve/authorize a county budget extension, due to a board being unable to agree.

Chairman Heitshusen called meeting back to order at 10:17 a.m.

Becky Fry, Iowa County Transportation Director met with the board to present monthly department update.

Motion by Schumacher, seconded by Montross to approve and authorize the chair to sign new Opioid Settlement Agreement/Participation Package with Teva, Allergan, CVS, Walgreens, and Walmart via DocuSign. All aye, motion carried.

Motion by Schumacher, seconded by Montross to approve and authorize chair to sign Resolution 2023-3-24 B as follows:

RESOLUTION 2023-3-24-B

Supporting the goals and ideals of National Public Health Week.

Whereas the week of April 3, 2023, is National Public Health Week;

Whereas the theme for National Public Health Week in 2023 is "Centering and Celebrating Cultures in Health";

- Whereas the goal of National Public Health Week in 2023 is to recognize the contributions of public health in—
 - (1) improving the health of the people of the United States; and
 - (2) achieving health equity;
- Whereas, as of the date of introduction of this resolution, the United States and the global community are responding to the COVID–19 pandemic, which requires support for—
 - (1) a robust public health infrastructure and workforce;
 - (2) State, territorial, local, and Tribal health departments, health care workers, public health laboratories, and first responders;
 - (3) diagnostic testing of new and potential COVID-19 cases and activities related to epidemiology and public health data;
 - (4) complying with appropriate social distancing and quarantine recommendations;
 - (5) relieving financial burdens for individuals in the United States hurt by the COVID–19 pandemic, including through public health emergency leave;
 - (6) State Medicaid programs and community health centers to ensure care for vulnerable populations;
 - (7) collaboration among the Federal Government, State and local governments, schools, businesses, and employers to support public health measures to decrease community spread of COVID–19;
 - (8) investments in the Centers for Disease Control and Prevention, which support infectious disease outbreak preparedness and critical public health infrastructure for State and local health departments and public health laboratories;
 - (9) a comprehensive effort to ensure a successful COVID-19 vaccination campaign that boosts access to vaccines for vulnerable populations and trust in vaccine safety and effectiveness; and
 - (10) efforts to address racism as a public health crisis and reduce racial and ethnic health disparities related to COVID–19 deaths, vaccine access and testing, and important health outcomes outside of the pandemic such as maternal mortality;
- Whereas, in 2020, the life expectancy at birth for the population of the United States declined by 1.5 years, which is the largest drop in life expectancy since 1943;
- Whereas many of the leading causes of death for individuals in the United States result from chronic conditions, which are among the most common, costly, and preventable of all health challenges;
- Whereas there are significant differences in the health status of individuals living in the healthiest States and those living in the least healthy States, including differences in obesity rates, the prevalence of chronic disease, and the prevalence of infectious disease;
- Whereas racial and ethnic minority populations in the United States continue to experience disparities in the burden of illness and death, as compared with the entire population of the United States;
- Whereas violence is a leading cause of premature death, and it is estimated that more than 7 individuals per hour die a violent death in the United States;
- Whereas deaths from homicides cost the economy of the United States billions of dollars, and the violence of homicides can cause social and emotional distress, community trauma, injury, disability, depression, anxiety, and post-traumatic stress disorder;
- Whereas over 47,500 lives were lost due to suicide in 2019, and in May 2020, during the COVID–19 pandemic, emergency department visits for suspected suicide attempts began to increase among adolescents aged 12–17 years, especially among girls;

- Whereas an estimated 1 in 7 children in the United States experience child abuse and neglect, with 1,840 children dying of abuse and neglect in 2019;
- Whereas despite significant progress in reducing the infant mortality rate in the United States to a historic low of 5.6 infant deaths per 1,000 live births in 2019, the infant mortality rate in the United States still greatly varies among States;
- Whereas women die from pregnancy-related complications in the United States at a higher rate than in many other developed countries, and an estimated 60 percent of maternal deaths in the United States are preventable;
- Whereas Black mothers experience a maternal mortality rate 3 to 4 times higher than White mothers;
- Whereas there were an estimated 100,306 drug overdose deaths in the United States during the 12-month period ending in April 2021, the highest level ever recorded during a 12-month period, and this was an increase of 28.5 percent from the 78,056 deaths during the same period the year before;
- Whereas cigarette smoking is the leading cause of preventable disease and death in the United States, accounting for more than 480,000 deaths every year, including more than 41,000 deaths resulting from secondhand smoke;
- Whereas the percentage of adults in the United States who smoke cigarettes has decreased from 20.9 percent of the population in 2005 to 13.7 percent of the population in 2018;
- Whereas, in 2020, according to data from the National Youth Tobacco Survey, 19.6 percent of high school students (3,020,000 students) and 4.7 percent of middle school students (550,000 students) reported current e-cigarette use;
- Whereas data from the National Youth Tobacco Survey showed that in 2020 almost 40 percent of high school e-cigarette users were using an e-cigarette on 20 or more days out of the month, and almost a quarter of high school e-cigarette users were using e-cigarettes every day, indicating a strong dependence on nicotine among youth;
- Whereas in the past 2 decades heat-related mortality for older persons has almost doubled, reaching a record high 19,000 of deaths in 2018;
- Whereas, from 2018 to 2019, the United States spent nearly \$13 per person on climate change adaptation in the health sector, far less than what is needed to prevent the growing health impacts of climate change;
- Whereas, in 2016, fine particulate air pollution led to more than 64,000 premature deaths in the United States, and Black and Hispanic individuals in the United States were disproportionately impacted;
- Whereas voting helps shape the conditions in which people can be healthy, and good health is consistently positively associated with higher likelihood of voter participation;
- Whereas public health organizations use National Public Health Week to educate public policymakers and public health professionals on issues that are important to improving the health of the people of the United States:
- Whereas studies show that small strategic investments in disease prevention can result in significant savings in health care costs;

- Whereas vaccination is one of the most significant public health achievements in history and has resulted in substantial decreases in—
 - (1) the number of cases, hospitalizations, and deaths associated with vaccine-preventable diseases; and
 - (2) health care costs associated with vaccine-preventable diseases;

Whereas each 10-percent increase in local public health spending contributes to a—

- (1) 6.9-percent decrease in infant deaths;
- (2) 3.2-percent decrease in deaths related to cardiovascular disease;
- (3) 1.4-percent decrease in deaths due to diabetes; and
- (4) 1.1-percent decrease in cancer-related deaths;

Whereas public health professionals help communities prevent, prepare for, mitigate, and recover from the impact of a full range of health threats, including—

- (1) disease outbreaks, such as the COVID-19 pandemic;
- (2) natural disasters, such as wildfires, flooding, and severe storms; and
- (3) other disasters, including disasters caused by human activity and public health emergencies;

Whereas public health professionals collaborate with partners outside of the health sector, including city planners, transportation officials, education officials, and private sector businesses, recognizing that other sectors can influence health outcomes;

Whereas in communities across the United States, individuals are changing the way they care for their health by avoiding tobacco use, eating healthier, increasing physical activity, and preventing unintentional injuries at home and in the workplace; and

Whereas efforts to adequately support public health and the prevention of disease and injury can continue to transform a health system focused on treating illness into a health system focused on preventing disease and injury and promoting wellness: Now, therefore, be it

Resolved, That the Iowa County Board of Supervisors—

- (1) recognizes the goals and ideals of National Public Health Week;
- (2) recognizes the efforts of local public health professionals, communities, and individuals in preventing disease and injury;
- (3) recognizes the role of public health in—
- (A) preventing and responding to infectious disease outbreaks;
- (B) mitigating short-term and long-term impacts of infectious disease outbreaks on the health and wellness of individuals in the community;
- (C) addressing social and other determinants of health, including health disparities experienced by minority populations; and
- (D) improving the overall health of individuals in the community;
- (4) encourages increased efforts and resources to—
- (A) improve the health of individuals in the community; and
- (B) make the County, in one generation, the healthiest County in the state by—
- (i) providing greater opportunities to improve community health and prevent disease and injury; and
- (ii) strengthening the public health system and workforce in the County; and
- (5) encourages the people of the County to learn about the role of the public health system in improving health in the County.
