December 8, 2023

The Iowa County Board of Supervisors met on December 8, 2023. Heitshusen, Chairman called the meeting to order at 9:00 a.m. Degen, Heitshusen, Maas, Montross and Schumacher were present.

Motion by Schumacher, seconded by Maas to approve the agenda. All aye, motion carried.

Motion by Schumacher, seconded by Degen to **approve** minutes from December 1, 2023. All aye, motion carried.

**Chair Note:** The Iowa County Board of Supervisors approved handwritten claims paid with warrant numbers 27569 & 27732. Board approved payroll paid with warrant number 27570 – 27731.

Motion by Maas, seconded by Montross to accept resignation from Board of Supervisors Compensation Board Representative Susan Schaefer effective immediately. All Aye, motion carried.

Maas nominated Brian Strasser to fill the vacancy of the Board of Supervisors Compensation Board Representative.

Heitshusen nominated Gary Boland to fill the vacancy of the Board of Supervisors Compensation Board Representative.

After discussion of the nominees the Board unanimously chose to rescind official nominations and will vote for either Brian Strasser or Gary Boland to fill the vacancy of the Compensation Board Representative by paper vote.

Votes were tallied by the Auditor; results were three votes for Gary Boland and two votes for Brian Strasser.

Gary Boland was appointed by paper ballot as Iowa County Board of Supervisors Compensation Board Representative to fulfill term of Susan Schaefer to expire June 30, 2024.

Nick Amelon, Iowa County Engineer, presented the Board with his weekly department report, discussing cutting brush, grading, hauling stockpile rock, throwbacks, bridge survey, submitting check plans, sign replacement grant and pre-trip inspection forms. Amelon also delivered a presentation of the annual update and upcoming budgeting.
