AMENDMENT TO THE IOWA COUNTY ORDINANCE NO. 22 WHICH ORDINANCE IS KNOWN AS THE IOWA COUNTY SNOW & ICE POLICY  
SECTION 3. Purpose. It is the purpose of this amendment to clearly state the operating hours of snow removal units in Iowa County.

SECTION 2. Amendment Effect. Except as amended heretofore, all of the other terms and provision of Iowa County Ordinance No. 22 shall remain in full force and effect.

SECTION 3. When Effective. This resolution amending Iowa County Ordinance No. 22 shall be effective after its final passage, approval and publication as provided by law.
