You are hereby and herein notified that the Board of Supervisors of Iowa County, Iowa, will at 9:45 a.m. on the 7<sup>th</sup> day of November, 2025 make a decision as to whether the following Ordinance No. 43 shall be enacted.

### COUNTY HOME RULE ORDINANCE NO. 43

**TITLE:** An ordinance readopting the existing county code and repealing certain provisions therein, Iowa County, Iowa.

**Section 1: Purpose.** Iowa Code Section 331.302(10)(a) requires that once every five years a County shall compile its code of ordinances. This ordinance readopts ordinances already in effect, and repeals any ordinance deemed no longer necessary to the operation of Iowa County, Iowa, or to the health, safety, and welfare of its citizens.

**Section 2. Readoption.** The following ordinances have been previously adopted and enacted into law and were duly published as the law provides. They are stated herein by number and subject matter and the ordinances have been renumbered to provide for the correct numerical order and comprise the Iowa County Code of Ordinances:
