**TERMS OF AGREEMENT**

- Paved Roads must be bored. Advanced authorization is required for boring granular roads.
- Under no conditions will a trench for tile crossing be left open overnight.
- No trenching shall occur between November 15 and April 1, unless authorized by County Engineer.
- The Applicant shall construct, backfill, compact, place roadstone, and restore road to its original condition.
- All necessary and proper barricades, shall be furnished by and maintained by the Applicant.
- All signing and barricades must be in accordance with the 2009 MUTCD.
- Tile Intakes shall not be placed within the Right-of-Way.
- All tile crossings must stay 25 ft. away from all culverts and bridges.
- All tile crossings are to be properly connected on both ends to existing field tile.
- No payment shall be made (or pipe furnished) for tile crossings that are connected to sanitary sewer tile.

### TERMS OF AGREEMENT (Continued)

- All requests shall be submitted to the Iowa County Engineer's Office two weeks before construction.
- The Applicant shall give notice of construction to Engineer's Office 2 working days prior. The permit expires within 90 days of being granted.
- The Applicant shall pay the contractor for work performed. In order to be reimbursed the Applicant must provide proof to Iowa County that the Contractor has been paid. After proof has been provided Iowa County will reimburse the Applicant up to \$500 for a trenched crossing or up to \$1,400 for a bored crossing or up to \$400 per each side of road for unplugging/fixing of existing tile crossing within the right of way. Applicant shall be reimbursed for the tile material, the engineer has set prices for tile based on size of tile. Contact Engineer's Office for current prices.
- Tile shall be Schedule 40 and have a minimum diameter of 6 inches.

Failure to comply with ANY of the terms set forth above will result in Non-Compliance. Tile crossings in Non-Compliance may result in a NON-REIMBURSEMENT from the County.
